

CCPA Privacy Policy

At ReCharge, Inc. (hereinafter “ReCharge”) we strive to keep your Personal Information confidential. By ensuring that you are aware of and understand the ReCharge Customer Privacy Policy, we can provide you with better service. Please take a moment to read the following policy to learn how we handle your Personal Information.

Personal Information we Collect

ReCharge may collect the following category of personal data:

- **Identifiers** (Name, Email Address, Phone Number, and Postal Address)
- **Online Identifiers** (Cookies and similar technology)
- **Commercial Information** (Last four digits of credit card number, products you have ordered or considered, as well as your purchasing history)
- **ReCharge Employee Information** (Name, Phone Number, Postal Address, Employee identification number, and other identifiers necessary for the processing of payroll and benefits)

Why we Collect your Personal Information

ReCharge collects and uses your personal information as set forth above and as otherwise collected from you (“Personal Information”) to provide key services such as coordination with our merchants (“Merchants”) and other partners (“Partners”) or processing customer transactions and payments. Personal Information is not collected for purposes outside of those discussed in this policy without explicit consent.

How we Collect your Personal Information

We collect Personal Information from our Merchants, our Merchants’ customers, and our Partners. Merchant data is collected via our Platform Partners upon the installation of the ReCharge Payments application. Merchants’ customers Personal Information is collected during checkout as part of the buying and selling process. Partner Personal Information is collected upon registration with ReCharge.

With Whom your Personal Information is Shared

Personal Information may be shared with third-parties to perform services for ReCharge, Merchants, Merchants’ customers, and Partners. The third-party providers used by us will only collect, use, and disclose your information to the extent necessary to allow them to perform the services they provide to you and to us.

- We may share customer name, email, phone, shipping and billing address information of Merchant's customers with our Platform Partners.
 - We provide this information to our Platform Partners in order to provide our Merchants with our service.
- We may share credit card and billing address information of Merchant's customers with payment gateways.

- We provide this information to payment gateways in order to provide our Merchants with our service.
- We may share shipping address information of Merchant's customers with address validation and fulfillment services.
 - We provide this information to fulfillment services in order to provide our Merchants with our service.

Certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information we are required to provide to them for your purchase-related transactions.

For these providers, we recommend that you read their privacy policies so you can understand the manner in which your Personal Information will be handled by these providers.

Any Personal Information transferred to a third party for data processing is processed in accordance with our instructions, and is subject, by law, to a comparable level of protection as that provided by ReCharge.

ReCharge will always ask for your consent before sharing your Personal Information with a Third Party for purposes other than those described in this section.

Right to Request Disclosure and Deletion

As a consumer, you have the right to request the disclosure about collection, use, disclosure, and sale of Personal Information from ReCharge. You also have the right to request the deletion of your Personal Information from ReCharge.

Both Merchants and their customers have full access to update or delete their Personal Information from the Merchant admin access or the Customer Portal. If you are unable to change any Personal Information, please contact us to make the changes. It is important to remember that if you delete or limit the use of your Personal Information, the Services we provide may not function properly.

Non-Discrimination

ReCharge will not discriminate you the consumer for exercising any of your rights stated within this privacy policy.

Sale and Disclosure for Business Purposes

ReCharge does not sell your Personal Information. ReCharge does disclose your Personal Information with other ReCharge business units and other companies that help us provide products and services to you, and we may provide your Personal Information to these companies.

ReCharge does not knowingly solicit Personal Information from children or send them requests for Personal Information. If you believe that your child under the age of 13 has submitted Personal Information to ReCharge, and without prior verifiable parental consent, please contact us at privacy@rechargeapps.com so that we can take steps to delete the Personal Information they provided.

If we are going to use your Personal Information differently from that stated at the time of collection, we will try to contact you via email using the most recent information we have. If you have not given us permission to communicate with you, you will not be contacted, nor will we use your Personal Information in a new manner.
